

The average expenditure per household in 2013 was less than in 2006 in the Basque Country

However, expenditure on housing, water, electricity and gas rose by 26%

Average household expenditure was 32,720 euros in 2013, 1.3% less than the previous year, and even less (-1.2%) than the figure registered seven years before, in 2006, according to Eustat data. By expenditure group, Basque homes maintained the same average household spending on *Housing, water, electricity and other fuels*, the largest category, with zero growth with respect to the previous year, even though there was a significant increase (26.0%) compared to 2006. In second place in terms of category size, expenditure on *Food and non-alcoholic beverages*, although it increased by 2.1% with respect to 2012, registered a fall of 0.6% with respect to 2006.

Spending on *Transport* also fell sharply with respect to 2006 (-31.7%), and compared with 2012 (-10.0%). Other types of expenditure, however, registered significant growth, although they account for less of the total. Thus, expenditure on *Health* rose by 13.1% with respect to the previous year and 10.9% in relation to 2006, and expenditure on *Education* grew by 13.4% and 26.1%, respectively. In addition, the contraction in family spending on *Leisure, entertainment and culture*, by 11.5% with regards to the previous year, was significant; as was spending on *Hotels, cafés and restaurants* (-4.3%).

If we focus on the **structure of expenditure**, the three main expenditure groups in the consumption structure of Basque households in 2013 were *Housing, water, electricity, gas and other fuels*, accounting for an average total household expenditure of 35.3%, followed by *Food*

and non-alcoholic beverages, at 14.2% and expenditure on *Hotels, cafés and restaurants* at 9.7%. Following these were *Transport* (9.1%), *Other goods and services* (7.3%) and *Clothes and Footwear* (5.3%).

Since 2006, the type of expenditure in the budget of Basque households that has increased the most is housing expenditure, from 27.7% to 35.3%; up by almost eight percentage points. Spending on transport, however, decreased by 4 percentage points, from accounting for 13.2% of household spending 2006 to 9.1% in 2013, all of which is in current terms. Food still accounted for 14% of the family budget, whereas spending on leisure, culture, hotels and restaurants became less significant compared to 2006, going from 17.8% to 15% of the family budget in 2013.

The **average expenditure per person** stood at 13,573 euros, with an decrease in current euros of 0.4% compared to 2012.

In absolute terms, **total expenditure** on consumption in 2013 fell by 1.1% with respect to 2012, with different trends in the various expenditure groups. Thus, the two most significant groups in order of expenditure, *Housing, water, electricity, gas and other fuels* and *Food and non-alcoholic beverages* were up by 0.3% and 2.4% respectively. However, the level of total expenditure on *Hotels, cafés and restaurants* was down by 4.0%. The most significant decrease in percentage terms was produced in *Leisure, entertainment and culture* with an expenditure situated at 1.552 billion euros (11.3% down on the previous year). In contrast, the highest growth was in the area of *Education*, with 13.7%, followed by *Health* (13.4%).



If we look at the average household expenditure **according to the level of net monthly household income**, significant differences can be seen between households with the lowest and the highest incomes. In 2013, in households with a monthly income below 1,000 euros there was an average annual expenditure per household of 17,711 euros, whilst households with a monthly income of 3,000 euros was almost triple this amount, with an annual expenditure of 51,725 euros.

With respect to 2012, there was a decrease in average household expenditure in households with an income of between 2,000 and 2,999 euros, with a decrease of 1.8%. In the remaining households there was a slight increase in average expenditure per household.

Finally, if we observe expenditure **according to the geographical location of the family**, the largest average household expenditure was produced in municipalities of fewer than 10,000 inhabitants, with an expenditure of 33,945 euros per household, 3.7% above the average for the Autonomous Region. The lowest average expenditure per household (€32,216) was produced in households situated in municipalities of between 10,000 and 100,000 inhabitants.

By **province**, families in Álava implemented 13.7% of the total expenditure in the Basque Country in 2013, Bizkaia accounted for 53.8% of the total and Gipuzkoa 32.5%.
